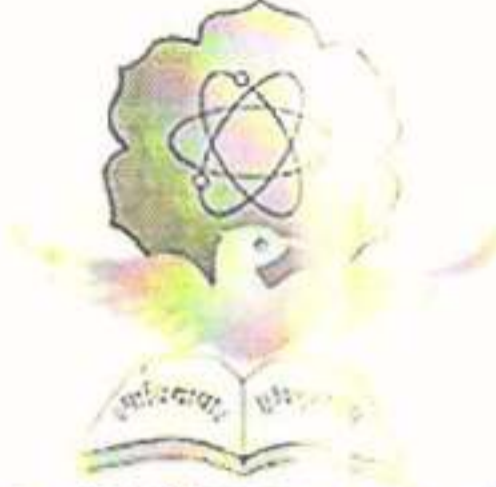

 - exchange necessary reference books and other resources of library
 - promote institutional exchanges by inviting Librarians to participate in a variety of activities to develop Library services
 4. Each institution shall designate a coordinator to oversee and facilitate the implementation of this MOU. In the event the designated coordinator changes, each cooperating instution agrees to promptly communicate that change including the name and contact information for the new coordinator. The coordinators, working with other

appropriate administrators at the respective universities, shall have the following responsibilities:

- to promote academic collaboration at both faculty, graduate and undergraduate student levels for research and study;


